**THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.**

ORDER MADE UNDER SECTION 13 (2).

I, the Governor, in exercise of the powers conferred by section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, do hereby order that the Order relating to the Tree Planting Area of the village of Ayios Photios, published in the *Gazette* of the 16th February, 1934, under Notification No. 230, shall be extended for a further period of five years from the date of the expiration thereof.

**THE FOREST LAW, 1939.**

REGULATIONS MADE UNDER SECTION 13.

I, the Governor in Council, in exercise of the powers conferred by section 13 of the Forest Law, 1939, do hereby make the following regulations:—

1. These regulations may be cited as the Forest (Amendment) Regulations 1944, and shall be read as one with the Forest Regulations, 1940 to 1942, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Forest Regulations, 1940 to 1944.

2. Regulation 6 of the principal Regulations is hereby amended by the insertion therein immediately after paragraph (b) of the following paragraph:—

"(bb) as a Municipal Fuel Area ; "

3. The principal Regulations are hereby amended by the insertion therein immediately after regulation 8 of the following regulation:—

"Municipal Fuel Areas. 8A. The Governor may by order published in the *Gazette* direct that any Minor State Forest or any part thereof reserved as a Municipal Fuel Area shall be under the control of the Council of such Municipal Corporation as may be specified in the order and thereafter the provisions of regulations 8 and 12 shall apply to such Fuel Area subject to the following adaptations and modifications, that is to say—

- (a) the Council of the Municipal Corporation specified in the Order shall be substituted for Village Commission or Village Commissions as the authority having the rights and liabilities under the regulations ;
- (b) any rules required to be posted up shall be posted outside the municipal offices ;
- (c) whenever the words ' Village Fuel Area ' occur, the words ' Municipal Fuel Area ' shall be substituted therefor ;
- (d) whenever the words ' Village Forest Fund ' occur, the words ' Municipal Forest Fund ' shall be substituted therefor."
