Whereas it has been represented to me that it is desirable in the public interest to erect a cotton spinning factory (with the necessary appurtenances thereto) in the Ibrahim Pasha Quarter of the town of Nicosia:

Now, therefore, I Charles Campbell Woolley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross, by virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1936, do hereby declare the erection of the cotton spinning factory (with the necessary appurtenances thereto) aforesaid to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Controller of Supplies the supervision and effectuation of the said undertaking.
