### THE SUMMER TIME LAW, 1940.

ORDER MADE UNDER SECTION 2.

C. C. WOOLLEY, Governor.

I, the Governor, in exercise of the powers conferred by section 2 of the Summer Time Law, 1940, do hereby order as follows:—

1. This Order may be cited as the Summer Time Order, 1944.

2. During the period specified in the Schedule hereto the time for legal and general purposes in the Colony shall be three hours in advance of Greenwich Mean Time.

#### SCHEDULE.

From midnight (Greenwich Mean Time) on the 31st March, 1944, to midnight (Greenwich Mean Time) on the 31st October, 1944.

THE TRADING WITH THE ENEMY (CUSTODIAN) ORDERS, 1940 AND 1941.

## ORDER MADE BY THE GOVERNOR.

C. C. WOOLLEY,

Governor.

I, the Governor, in exercise of the powers conferred by sub-section (2) of section of the Trading with the Enemy Laws, 1939 to 1943, and by sub-section (2) of section as of the Trading with the Enemy (Custodian) Orders, 1940 and 1941, and of every other power hereunto enabling, do hereby order as follows:—

1. This Order may be cited as the Trading with the Enemy (East Africa, Charles and Control of the Control of t

Cyrenaica and Tripolitania) Order, 1944.

2. Notwithstanding anything contained in section 3 of the Trading with the Enemy Laws, 1939 to 1943, any person, unless I otherwise direct, may trade within 16 of 1939 any of the territories formerly known as Italian East Africa, Cyrenaica and Tripolitania with any individual or body of persons (whether corporate or unincorporate) 28 of 1940 carrying on business therein.

- 3. Clause 3 of the Trading with the Enemy (Custodian) Orders, 1940 and 1941, shall not apply to any money payable by reason of a transaction authorized by clause 2 of this Order.
- 4. The Authorization published in Supplement No. 3 to the Gazette of the 28th 11. 9.1940 August, 1941, under Notification No. 212 (relating to trading with any body of persons carrying on business in any territories formerly known as Italian East Africa), is hereby revoked without prejudice to anything done thereunder.
