I, the Governor's Deputy in Council, in exercise of the powers conferred on the Governor by section 65 of the Customs Laws, 1936 to (No. 2) 1942, do hereby order as follows:—

1. This Order may be cited as the Wharfage Dues (Export of Unrefined Pyrites) Order, 1944.

2. There shall be levied and collected upon the export from the Colony of unrefined pyrites, wharfage dues at the special rate of one and a half piastres per ton.

3. This Order shall be deemed to have come into operation on the 1st January, 1943.
