No. 79. **THE FOREST LAW, 1939.**
ORDER IN COUNCIL No. 2117
MADE UNDER SECTION 3.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment No. 2) Order, 1944, and shall be read as one with the Minor State Forests (Famagusta) Orders, 1943 to 1944, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to (No. 2) 1944.

2. The Schedule to the principal Order is hereby amended by the addition at the end thereof of the following areas:—

" 18. *Lefkoniko in the District of Famagusta* :—

All the area at the locality 'Vikles' demarcated by boundary stones from X6527 to X6543 being plot Nos. 138, 139, 147 (part), 148, 150, 151 and 152 of the Government Survey Plan No. XIV.44E, comprising 31 donums and 3 cvleks and shown on the Government Survey Plan Serial No. 1292.

19. *Kouklia in the District of Famagusta* :—

All that area at the locality 'Trakhonas or Petradhes' demarcated by boundary stones from X5034 to X5039 being part of plot No. 105 of the Government Survey Plan No. XXXII.21E., comprising 9 donums and 2 cvleks approximately and shown on the Government Survey Plan Serial No. 1291."

No. 80. THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

I, the Governor, in exercise of the powers conferred by section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, do hereby order that the Order relating to the Tree Planting Area of the village of Stroumbi, published in the *Gazette* of the 6th October, 1933, under Notification No. 915, shall be extended for a further period of five years from the date of the expiration thereof.

2. This Order shall be deemed to have come into force on the 5th day of November, 1943.
