No. 111. THE LAND ACQUISITION LAWS, 1899 TO 1944.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas it is desirable in the public interest to acquire the lands known as the Akhelia, Kouklia, Mamonia and Potima chiftliks in Paphos District (including the rivers by which they are irrigated), for the purpose of improving those lands by means of irrigation works, and by such other measures as may be necessary to secure the proper cultivation of those chiftliks and the proper utilization of the waters of the aforesaid rivers :

Now, therefore, I, Charles Campbell Woolley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, by virtue of the powers vested in me by sections 2 and 3 of the Land Acquisition Laws, 1899 to 1944, do hereby declare the acquisition of the said lands (including the aforesaid rivers) to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby, by virtue of the powers vested in me by section 4 of the said Laws, entrust the supervision of the said undertaking to the Director of Land Registration and Surveys.

NOTE : In due course His Excellency the Governor may sanction the above acquisition under section 6 of the above-mentioned Laws, or, in the first place, require the value of the lands (including the rivers) and the amount to be paid by way of compensation for the same to be ascertained under the proviso to section 7 of the said Laws.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas it has been represented to me that it is desirable in the public interest to erect a lairage (with the necessary appurtenances thereto) within the town of Famagusta.

Now, therefore, I, Charles Campbell Woolley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the decoration of the Military Cross, by virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1944, do hereby declare the erection of the lairage (with the necessary appurtenances thereto) aforesaid to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Director of Public Works the supervision and effectuation of the said undertaking.
