In this part of the Schedule the term 'wholesale' means sale or purchase at any one time or at any single transaction in quantities in excess of 100 okes, whether of one or more of the aforementioned qualities together.

Modification :—The prices set out in this part of the Schedule shall not apply to sole leather pieces known as 'farsa'.
