**No. 190. THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 TO 1942.**

**NOTICE No. 172 UNDER CLAUSE 13.**

A.—The Schedule is hereby amended with effect from the 1st July, 1945, by the deletion therefrom of Part 6 and the substitution therefor of the following Part:—

the term ‘wholesale’ means sale or purchase of pure ground coffee in quantities in excess of 5 okes at any one time or at any single transaction.”

B.—Part 17 of the Schedule is hereby amended by the deletion therefrom of the retail and wholesale prices relating to tyri and the substitution therefor of the following prices:—
