THE DEFENCE REGULATIONS, 1940 TO 1945.

ORDER MADE BY THE SUPERINTENDENT OF THE PORT OF FAMAGUSTA.

In exercise of the powers vested in the Governor by regulation 45 of the Defence Regulations, 1940 to 1945, which were duly delegated to me by the Order of the Governor dated the 22nd December, 1941, and published in Supplement No. 3 to the *Gazette* of the 31st December, 1941, under Notification No. 323, I, Archibald Benson Cavaghan, Superintendent of the Port of Famagusta do hereby make the following order :—

1. This order may be cited as the Port of Famagusta (Public Traffic) (Amendment No. 2) Regulations, 1945, and shall be read as one with the Port of Famagusta (Public Traffic) Regulations, 1941 to 1945, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Port of Famagusta (Public Traffic) Regulations, 1941 to (No. 2) 1945.

2. The principal Regulations are hereby amended as follows :—

- (a) by the deletion therefrom of Part I (relating to Entrance to the Port), Part II (relating to Internal Movements) and Part VI (relating to List of Authorities concerned with the Regulations from whom Permission to do Certain Acts is to be obtained);
- (b) by the renumbering of Parts III, IV and V and paragraphs 29, 30, 31, 32 and 33 as Parts I, II and III and paragraphs 6, 7, 8, 9 and 10, respectively.
