NOTIFICATION UNDER CLAUSE 3 (1).

In exercise of the powers vested in me under clause 3 (1) of the Defence (Heaters Control) Orders, 1944 and 1945, I hereby declare the 22nd August, 1945, to be the date from and after which no person shall erect, use or work any wood burning heater of the following type without a licence from me, that is to say :—  
Stoves used for heating water in hotels, restaurants and public institutions.
