THE LAND ACQUISITION LAWS, 1899 TO 1944.

Notice is hereby given that the following lands, namely plots Nos. 34 and 35 of Plan No. XXXIII/12.3.I, Block " B ", Varosha Qr., Famagusta, demarcated by Boundary Stones Nos. 732, 737, 45 and 44, situated on the main road leading to the Famagusta harbour about 290 feet S.E. of the Jampulat Tabia Bastion are required by the Governor for an undertaking of public utility.

Any person claiming to have any right or interest in the said lands is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Governor is willing to treat for the acquisition of the said lands.

THE DEFENCE REGULATIONS, 1940 TO 1945.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1945, I hereby order as follows :—

1. This Order may be cited as the Defence (Olive Presses) Order, 1945.
2. In this Order—
  - " oil " means local olive oil ;
  - " press " means olive press ;
  - " registered keeper " means any person registered as a keeper of a press under this Order.
3. From and after the 31st day of August, 1945, no person shall keep or work a press of any kind unless such person is a registered keeper.
4. Any person desiring to be registered under this Order as a registered keeper shall complete and deliver to the Director of Agriculture at Nicosia a return in the form of, and containing the particulars set out in, the First Schedule to this Order.
5. Every registered keeper—
  - (a) shall keep on his premises a book in the form set forth in the Second Schedule to this Order wherein he shall enter, or cause to be entered, daily, the particulars set forth in the said Schedule ;
  - (b) not later than six days after the last day of each month, commencing from the month of September, 1945, shall complete and deliver to the Director of Agriculture at Nicosia a return in the form of, and containing the particulars set forth in, the Third Schedule to this Order.
6. Every registered keeper shall permit such person as I or the Director of Agriculture may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with or for the purpose of checking the correctness or accuracy of any return made under the provisions of this Order.
7. Any person who—
  - (a) acts in contravention of, or fails to comply with, any of the provisions of this Order ;
  - (b) makes, under any of the provisions of this Order, any return which is false in any material particular ;
  - (c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,
 is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to 1945.
