No. 301. THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE ACTING GOVERNOR UNDER SECTIONS 3 (2) AND 7 (1).

I, the Acting Governor, in exercise of the powers conferred on the Governor by sections 3 (2) and 7 (1) of the Trading with the Enemy Laws, 1939 to 1945, (hereinafter referred to as "the Law"), do hereby order as follows:—

1. This Order may be cited as the Trading with the Enemy (Authorization (Finland) Order, 1945.
2. Notwithstanding anything contained in section 3 of the Law, any person, unless I otherwise direct, may, except as provided in clause 3 hereof, trade within Finland with the Finnish state or with any individual or body of persons (whether corporate or unincorporate) carrying on business therein.
3. This Licence shall not extend to or authorize—
 - (a) the performance of any contract of insurance or re-insurance entered into with or for the benefit of any person within the description contained in clause 2 of this Order before the 20th August, 1945;
 - (b) the payment of any bill of exchange payable in the United Kingdom and drawn before the 20th August, 1945, to or for the benefit of any such person as aforesaid;
 - (c) the encashment of any coupons by or on behalf of any such person as aforesaid.
4. For the purpose of this Order "trade" is confined to supplying any goods to or for the benefit of the Finnish state or any individual or body of persons, (whether corporate or unincorporate) carrying on business therein, or to obtaining goods from the Finnish state, such individuals or bodies of persons, and is deemed to include—
 - (a) transactions incidental to supplying or obtaining such goods; and
 - (b) the paying, transmitting or receiving of any money, negotiable instrument or security for money in respect of such trade.
5. This Order shall be deemed to have come into operation on the 20th August, 1945.

No. 302. THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE ACTING GOVERNOR UNDER SECTIONS 2 (5) AND 9.

I, the Acting Governor, in exercise of the powers conferred on the Governor by sections 2 (5) and 9 of the Trading with the Enemy Laws, 1939 to 1945, (hereinafter referred to as "the Law"), do hereby order as follows:—

1. This Order may be cited as the Trading with the Enemy (Custodian (Denmark) Order, 1945.
2. Clauses 3, 6 and 7 of the Trading with the Enemy (Custodian) Orders, 1940 and 1941, (requiring payment of certain moneys to the Custodian and imposing restrictions and requirements in regard to certain property in the Colony) shall not apply to—
 - (a) any money which would but for the existence of a state of war become payable to or for the benefit of any person within the description contained in clause 3 of this Order on or after the 20th August, 1945;
 - (b) any property which on or after the 20th August, 1945, comes into the ownership of any such person as aforesaid;

- (c) any money or property to which the above-mentioned clauses would apply only because any such persons as aforesaid became resident or commenced or recommenced to carry on business in Denmark on or after the 20th August, 1945.
3. This Order applies—
- to any individual resident in Denmark ;
 - as respects any business carried on in Denmark to any individual or body of persons (whether corporate or unincorporate) carrying on that business ;
 - as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 9 of the Law in accordance with the provisions of section 12A or section 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as controlled by any individual resident in, or body of persons carrying on business in, Denmark.
4. This Order shall be deemed to have come into operation on the 20th August, 1945.

No. 303. THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE TREASURER UNDER SECTION 6.

I, the Treasurer, in exercise of the powers conferred by section 6 of the Trading with the Enemy Laws, 1939 to 1945, (hereinafter referred to as "the Law"), (which renders ineffective, except with my sanction, the transfer by or on behalf of enemies of negotiable instruments and choses in action), do hereby order as follows :—

1. This Order may be cited as the Trading with the Enemy (Transfer of Negotiable Instruments, etc.) (Denmark) Order, 1945.

2. I hereby sanction—

- any assignment of a chose in action ;
- any transfer of a negotiable instrument ; and
- any transfer of any coupon or other security transferable by delivery, not being a negotiable instrument,

being an assignment or transfer made on or after the 20th August, 1945, by or on behalf of a person to whom this Order applies.

3. This Order applies—

- to any individual resident in Denmark ;
- as respects any business carried on in Denmark, to any individual or body of persons (whether corporate or unincorporate) carrying on that business ;
- as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 6 of the Law in accordance with the provisions of section 12A or 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as the body is controlled by any individual resident in, or body of persons carrying on business in, Denmark.

4. This Order shall be deemed to have come into operation on the 20th August, 1945.
