2. Notwithstanding anything contained in section 3 of the Law, any person, unless I otherwise direct, may trade within Denmark with any individual or body of persons, (whether corporate or unincorporate) carrying on business therein.

3. The transfer by or on behalf of any person within the description contained in clause 4 of this Order of any annuities, stocks, shares, bonds, debentures or debenture stock registered or inscribed in any register, branch register or other book kept in the Colony which on or after the 20th August, 1945, comes into the ownership of any such person as aforesaid, is hereby sanctioned.

4. Clause 3 of this Order shall apply-

(a) to any individual resident in Denmark;

- (b) as respects any business carried on in Denmark to any individual or body of persons (whether corporate or unincorporate) carrying on that business:
- (c) as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 7 of the Law in accordance with the provisions of section 12A or section 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as controlled by any individual resident in, or body of persons carrying on business in, Denmark.

5. This Order shall be deemed to have come into operation on the 20th August, 1945.

## No. 305. THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE ACTING GOVERNOR UNDER SECTIONS 2 (5) AND 9.

## R. E. TURNBULL,

Acting Governor.

I, the Acting Governor, in exercise of the powers conferred on the Governor by sections 2 (5) and 9 of the Trading with the Enemy Laws, 1939 to 1945, (here-inafter referred to as "the Law"), do hereby order as follows :--

1. This Order may be cited as the Trading with the Enemy (Custodian) (Greece) Order, 1945.

2. Clauses 3, 6 and 7 of the Trading with the Enemy (Custodian) Orders, 1940 and 1941, (requiring payment of certain moneys to the Custodian and imposing restrictions and requirements in regard to certain property in the Colony) shall not apply to-

(a) any money which would but for the existence of a state of war become payable to or for the benefit of any person within the description contained in clause 3 of this Order on or after the 3rd September, 1945;

(b) any property which on or after the 3rd September, 1945, comes into the ownership of any such person as aforesaid;

- (c) any money or property to which the above-mentioned clauses would apply only because any such persons as aforesaid became resident or commenced or recommenced to carry on business in Greece on or after the 3rd September, 1945.
- 3. This Order applies-
- (a) to any individual resident in Greece;
- (b) as respects any business carried on in Greece to any individual or body
- of persons (whether corporate or unincorporate) carrying on that business: (c) as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 9 of the Law in accordance with the provisions of section 12A or section 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as controlled by any individual resident in, or body of persons carrying on business in, Greece.

4. This Order shall be deemed to have come into operation on the 3rd September,  $\frac{1}{5}$ 1945.
