

No. 33. THE PRISON DISCIPLINE LAW, 1879.
REGULATIONS MADE UNDER SECTION 4.

I, the Governor in Council, in exercise of the powers conferred by section 4 of the Prison Discipline Law, 1879, do hereby make the following regulations:—

1. These Regulations may be cited as the Prison (Special) Regulations, 1945, and shall be read in conjunction with the Prison Regulations, 1908 to 1943.
2. Notwithstanding anything contained in the Prison Regulations, 1908 to 1943—
 - (a) all duties and powers vested in, or exercised by, the Inspector of Prisons, under such Regulations shall be vested in, and exercised by, the Superintendent of Prisons and whenever such Regulations provide that anything may be done by the Superintendent of Prisons, subject to or with the approval or consent of the Inspector of Prisons, the same may be done by the Superintendent acting alone;
 - (b) the words "Resident Superintendent of the Central Prison" whenever they occur in such Regulations shall be deleted and the words "Superintendent of Prisons" substituted therefor;
 - (c) all duties and powers vested in, or exercised by, the Resident Superintendent of the Central Prison shall be vested in, and exercised by, the Superintendent of Prisons.
3. These Regulations shall be deemed to have come into force on the 1st January, 1945.

NOTICE No. 161 UNDER CLAUSE 13.

A.—Part 74 of the Schedule is hereby amended by the addition thereto of the following Modification:—

"Modification: Provided that where methylated spirit is sold in any village outside a radius of 3 miles of a Commissioner's office there may be added to the maximum retail price two piastres per oke."

B.—The Schedule is hereby amended by the deletion therefrom of Part 80 and the substitution therefor of the following part:—
