**No. 333.****THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.**

REGULATIONS, MADE BY THE ACTING GOVERNOR.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:—

1. These regulations may be cited as the Defence (Amendment No. 3) Regulations, 1945, and shall be read as one with the Defence Regulations, 1940 to (No. 2) 1945, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence Regulations, 1940 to (No. 3) 1945.

2. The following regulations shall be inserted in the principal Regulations immediately after regulation 95:—

"Extra-  
territorial  
jurisdiction  
of Assize  
Courts.

95A. Notwithstanding anything in these regulations or in any law or public instrument contained, an Assize Court shall have jurisdiction to try any offence whenever committed and whether committed within the Colony or not, being an offence against any of these regulations having effect abroad under section 3 of the Emergency Powers (Defence) Acts, 1939 and 1940."
