

**No. 338. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.****NOTICE UNDER SECTION 74 (1).**

In exercise of the powers vested in the Governor by section 74 (1) of the Elementary Education Laws, 1933 to 1944, and otherwise, His Excellency the Acting Governor is pleased to direct and it is hereby directed that the tax mentioned in section 65 of the said Laws payable by the Maronite tax-payers of the villages mentioned in the first column of the Schedule hereto shall be increased by the rate per thousand mentioned in the second column of the said Schedule hereto to provide the amount required for the payment of loans or annual maintenance of the Maronite schools of the said villages respectively.
