**No. 351. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.****ORDER MADE UNDER SECTION 71.**

Whereas His Excellency the Acting Governor has, under section 52 of the Elementary Education Laws, 1933 to 1944, ordered the Committee of Management for Maronite Schools to repair the school building and premises in the village of Karpasha, in the District of Kyrenia :

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws :

And whereas a loan amounting to the sum mentioned in the third column of the Schedule hereto, has, under section 51 (1) of the said Laws, been raised to meet the expense of repairing such building as aforesaid :

Now, therefore, in pursuance of the powers vested in the Governor by section 71 of the Elementary Education Laws, 1933 to 1944, His Excellency the Acting Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loan aforesaid the sum of money mentioned in the fourth column of the said Schedule hereto be recovered from the Maronite taxpayers of the village mentioned in the second column of the said Schedule in manner provided by section 74 of the said Laws.
