NOTICE UNDER SECTION 5.

Notice is hereby given that the following lands are required by the Governor for an undertaking of public utility :---

This land is more particularly defined as the area edged red and coloured yellow on the Government Survey Plan Serial No. 1313.

(5) The Rivers Ezuza also known as "Akhelia" river, Dhiarrizos also known as "Kouklia" and Paloudhiou also known as "Potima" from their respective sources to the sea and all their tributaries with all the water whether flowing on the surface or underground which goes to form these rivers and their tributaries.

Any person claiming to have any right or interest in the said lands is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest. The Governor is willing to treat for the acquisition of the said lands. The plans showing the lands described above are available for inspection at my office in Paphos.
