REGULATIONS MADE UNDER SECTION 5.

I, the Governor, in exercise of the powers conferred by section 5 of the Elementary

Education Laws, 1933 to 1944, do hereby make the following regulations:—
1. These regulations may be cited as the Elementary Education (Ages of Pupils) (Amendment) Regulations, 1945, and shall be read as one with the Elementary Education (Ages of Pupils) Regulations, 1934, (hereinafter referred to as "the

- principal Regulations "), and the principal Regulations and these regulations may together be cited as the Elementary Education (Ages of Pupils) Regulations, 1934 and 1945.

 2. The principal Regulations are hereby amended by the deletion therefrom or regulations 3, 4, 5 and 8 and the substitution therefor of the following regulations.

 "3. No child shall be admitted in or shall attend as a pupil any infant school

"3. No child shall be admitted in or shall attend as a pupil any infant school unless it has completed its fourth year of age:

Provided that a child who will complete its fourth year of age within one month after the date upon which an infant school first opens in any school year may be admitted in and attend an infant school at any time within fifteen days after that date.

4. No child shall be admitted in or shall attend as a pupil any elementary

school unless it has completed its sixth year of age:

Provided that a child who will complete its sixth year of age within one month after the date upon which an elementary school first opens in any school year may be admitted in and attend an elementary school at any time within fifteen days after that date.

5. Children who have completed their fourth year of age may be enrolled as pupils in any infant school and children who have completed their sixth year of age may be enrolled in any elementary school within fifteen days of the date upon which the school first opens in any school year:

Provided that the Director of Education may in his discretion, in special cases, authorize the enrolment and admission at any time during any school year—

(a) in any infant school, of any child between the ages of four and six years:

(b) in any elementary school, of any child between the ages of six and fourteen years.

8. No child shall be enrolled or shall continue to attend an elementary school after the end of the school year in which such child completes its fourteenth year of age."
