No. 89. THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1943.

No. 90. THE SUMMER TIME LAW, 1940.

I, the Governor, in exercise of the powers conferred by section 2 of the Summer Time Law, 1940, do hereby order as follows:—

1. This Order may be cited as the Summer Time Order, 1945.

2. During the period specified in the Schedule hereto the time for legal and general purposes in the Colony shall be three hours in advance of Greenwich Mean Time.

From midnight (Greenwich Mean Time) on the 15th April, 1945, to midnight (Greenwich Mean Time) on the 31st October, 1945.

No. 91. THE QUARANTINE LAW, 1932.

REGULATIONS MADE UNDER SECTION 6.

I, the Governor in Council, in exercise of the powers conferred by section 6 of the Quarantine Law, 1932, do hereby make the following regulations:—

1. These regulations may be cited as the Quarantine (Aircraft) Amendment Regulations, 1945, and shall be read as one with the Quarantine (Aircraft) Regulations, 1937 and 1943, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Quarantine (Aircraft) Regulations, 1937 to 1945.

2. Regulation 28 of the principal Regulations is hereby amended as follows:—

(a) By the deletion therefrom of sub-paragraph D (c) of paragraph (1) thereof.

(b) By the deletion therefrom of sub-paragraphs (a) and (b) of paragraph (2) thereof and the substitution therefor of the following sub-paragraphs:—

“(a) that the bearer has been inoculated for the first time more than ten days and less than four years previously; or

(b) that the bearer has been re-inoculated within the past four years; or”.
