THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)

ORDER MADE BY A COMPETENT ACTUAL REGULATION 61.

29 4-48, p. 19.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services Order, 1946, I hereby order as follows:

Defence (Agricultural Produce)

2. In this Order:

REFL.S.L.1948, 19.2.48, p. 54.

Agricultural Produce" means barley, wheat and vetches; "Producer" means any person who since the 1st September, 1945, has cultivated and produced any agricultural produce either by his own labour the produced any agricultural produce either

by his own labour or through his agents or servants;

"Agricultural Produce Controller" means an officer appointed by His Excellency the Governor as Agricultural Produce Controller.

"Agricultural Produce Controller."

Agricultural Produce Control Officer" means a person or Cooperative Society appointed as such by the Agricultural Produce Controller:

"Authorized Purchaser" means a person or body duly authorized by the Agricultural Produce Controller to purchase agricultural produce;

"Town" means the towns of Nicosia, Famagusta, Larnaca, Limassol, Paphos and Kyrenia and includes the area lying within a

radius of 3 miles from the District Court of each town.

3. From and after the 1st May, 1946, no person shall purchase any agricultural produce save under a written permit issued by the Agricultural Produce Controller or any person authorized by him on that behalf.

4. Save under a written permit issued by the Agricultural Produce Controller or any person authorized by him on that behalf, from and after the 1st May, 1946, no producer shall sell any agricultural produce

save to an authorized purchaser.

- 5. From and after 1st May, 1946, no person shall, save under a written permit issued by the Agricultural Produce Controller or by a person authorized by him on that behalf bring or cause to be brought any agricultural produce :-
 - (a) into any town from any place or area outside a town;

(b) from one village area to another village area.

6. No person who is not a producer shall have in his possession or under his control any agricultural produce in excess of the normal

requirements for his household and animals for one month.

7. Every person shall permit such person as the Agricultural Produce Controller or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

8. Any person who acts in contravention of or fails to comply with any of the provisions of this Order is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

9. Nothing contained in this Order shall apply to any agricultural produce in the possession of or under the control of the Government.
