THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

ORDER MADE BY THE GOVERNOR UNDER SECTION 207 (1).

*Governor.*

I, the Governor, in exercise of the powers conferred by section 207 (1) of the Municipal Corporations Laws, 1930 to 1945, do hereby order as follows :—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Nicosia) Order, 1946.

2. In this Order—

“licensed premises” means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law, 1943.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Order, 1945,—

(a) all licensed premises situated within the municipal limits of the villages of Kythrea and Morphou shall be closed and remain closed from 1 a.m. on the 12th day of May, 1946, until 6 a.m. on the 13th day of May, 1946 ;

(b) all licensed premises situated within the municipal limits of the town of Nicosia shall be closed and remain closed from 1 a.m. on the 26th day of May, 1946, until 6 a.m. on the 27th day of May, 1946.

**THE CYPRUS PENSIONS ORDERS AND LAWS, 1929 TO 1946.**

**REGULATIONS MADE UNDER SECTION 3.**

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Cyprus Pensions Orders and Laws, 1929 to 1946, and with the sanction of the Secretary of State, do hereby make the following regulations:—

1. These regulations may be cited as the Cyprus Pensions (Amendment) Regulations, 1946, and shall be read as one with the Cyprus Pensions Regulations, 1929 to 1944, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Cyprus Pensions Regulations, 1929 to 1946.

2. Regulation 11 of the principal Regulations is hereby amended by the deletion therefrom of the word "and" (line 5) and the substitution therefor of the word "or".

3. The proviso to regulation 19 (3) of the principal Regulations (as amended by the Cyprus Pensions (Amendment No. 2) Regulations, 1934) is hereby further amended by the deletion therefrom of the word "and" (line 9) and the substitution therefor of the word "or".

4. These regulations shall be deemed to have been made on the 25th day of April, 1946.
