THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE **REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the first Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows :---

1. This Order may be cited as the Defence (Sale of Government Clothing and other Textiles) (Amendment) Order, 1946, and shall be read Gazette: together with the Defence (Sale of Government Clothing and other Supplement Textiles) Order, 1946, (hereinafter referred to as "the principal Order"), No. 3: and the principal Order and this Order may be cited together as the Defence (Sale of Government Clothing and other Textiles) Order, 1946.

 $\frac{2}{2}$. The principal Order is hereby amended by the deletion therefrom of Clause 11 and the substitution therefor of the following Clause :--

"11. Every approved retailer, upon selling any Government clothing or other textiles, shall supply the purchaser with a signed numbered statement specifying the name of the purchaser, the articles sold, the price paid for such articles and the date of the sales and he shall keep a dupheate copy of such statement serially numbered ".

3. This Order shall be deemed to have come into operation on the 28th March, 1946.
