3. Notwithstanding anything contained in the Sale of Intoxicating

Liquors (Retailers Closing Hours) Order, 1945,—

(a) all licensed premises situated within the municipal limits of the town of Limassol shall be closed and remain closed from 1 a.m. on the 26th day of May, 1946, until 6 a.m. on the 27th day of May, 1946.

(c) all licensed premises situated within the municipal limits of the town of Famagusta shall be closed and remain closed from sunrise on the 26th day of May, 1946, until midnight on the same day.
