

No. 170. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

ORDER MADE BY THE GOVERNOR UNDER SECTION 207 (1).

I, the Governor, in exercise of the powers conferred by section 207 (1) of the Municipal Corporations Laws, 1930 to 1945, do hereby order as follows :—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Limassol) Order, 1946.

2. In this Order—

“ licensed premises ” means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law, 1943.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Order, 1945,—

(a) all licensed premises situated within the municipal limits of the town of Limassol shall be closed and remain closed from 1 a.m. on the 26th day of May, 1946, until 6 a.m. on the 27th day of May, 1946.

I, the Governor, in exercise of the powers conferred by section 207 (1) of the Municipal Corporations, Laws, 1930 to 1945, do hereby order as follows :—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Famagusta) Order, 1946.

2. In this Order—

“ licensed premises ” means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law, 1943.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Order, 1945,—

(a) all licensed premises situated within the municipal limits of the village of Lefkoniko shall be closed and remain closed from sunrise on the 19th day of May, 1946, until midnight of the same day ;

(b) all licensed premises situated within the municipal limits of the village of Akanthou shall be closed and remain closed from sunrise on the 19th day of May, 1946, until midnight on the same day ;

(c) all licensed premises situated within the municipal limits of the town of Famagusta shall be closed and remain closed from sunrise on the 26th day of May, 1946, until midnight on the same day.
