No. 251. THE IMMIGRATION LAWS, 1936 TO 1939.

REGULATIONS MADE UNDER SECTION 31.

C. C. WOOLLEY,

Governor.

I, the Governor in Council, in exercise of the powers conferred by section 31 of the Immigration Laws, 1936 to 1939, do hereby make the following regulations :-

1. These regulations may be cited as the Immigration (Registration of Gazettes: Aliens) Amendment Regulations, 1946, and shall be read as one with the Immigration (Registration of Aliens) Regulations, 1939 to 1940, (herein-after referred to as "the principal Regulations"), and the principal 28. 7.1939 Regulations and those regulations may teacther be sited as the Immigra-30.10.1940 Regulations and these regulations may together be cited as the Immigra. 30.10.1940 tion (Registration of Aliens) Regulations, 1939 to 1946.

2. Regulation 13 of the principal Regulations is hereby amended as follows :--

- (a) by the deletion from paragraph (c) thereof of the full stop and the substitution therefor of a semi colon;
- (b) by the addition at the end of paragraph (c) thereof of the word " and ";
- (c) by the addition immediately after paragraph (c) thereof of the following paragraph :---
 - " (d) any alien entering the Colony as a traveller, unless his stay in the Colony exceeds three months : Provided that the registration officer may at any time require any such alien to register upon giving him forty-eight hours' notice therefor in writing, and thereupon such alien shall comply with and be subject to the provisions of these Regulations."
