No. 304. THE CUSTOMS LAWS, 1936 TO (No. 2) 1945.

ORDER IN COUNCIL No. 2205 MADE UNDER SECTION 52.

I, the Governor in Council, in exercise of the powers conferred by section 52 of the Customs Laws, 1936 to (No. 2) 1945, do hereby order as follows:—

1. This Order may be cited as the Import Duty (Water Softening Apparatus and Machinery) Exemption Order, 1946.

2. Water Softening Apparatus and Machinery and any parts thereof shall be admitted into the Colony free from all import duties.

THE EMERGENCY LAWS (TRANSITIONAL PROVISIONS) (CYPRUS) ORDER, 1946.

ORDER MADE UNDER DEFENCE REGULATION 40.

C. C. WOOLLEY,

_Governor.

I, the Governor, in exercise of the powers conferred by Defence Regulation 40 as set out in the Schedule to the Emergency Laws (Transitional Provisions) (Cyprus) Order, 1946, do by this Order declare that the area set out in the Schedule hereto shall, until further order, be a protected place for the purposes of the said regulation and that, save with a permission under the hand of the Officer Commanding, Headquarters, Cyprus or any officer authorized by him in that behalf and, subject to such directions as may be contained in the permission, no person shall be in such place:

Provided that nothing in this Order shall apply to any illegal immigrant detained in such area under the provisions of the Illegal Immigrants (Detention) Laws, 1946.

SCHEDULE.

The boundary commences at the boundary stone No. 1 in plot No. 6 of Ayios Loucas, Block "D" of the Government Survey Plan No. XXIV/ 59.E.1 locality "Karaolos" and proceeds north-eastwards in a straight line to boundary stone No. 2; thence in the same direction to the sea shore; thence in a direction at a bearing of 62° for a distance of 1,230 feet to a point in the sea; thence in a direction at a bearing of 152° for a distance of 7,075 feet (approximately), to a point in the sea. (This latter boundary line passing not less than 1,000 feet from any point on the shore); thence in a direction at a bearing of 242° for a distance of 1,290 feet to boundary stone No. 3, on the eastern boundary of plot No. 182 of Ayios Loucas, Block "C" of the Government Survey Plan No. XXIV/60. W.2, locality "Phanari"; thence south-westwards passing through boundary stones Nos. 4, 5, 6, 7, 8, 9, 10, 11 and 12; thence northwards passing through boundary stones Nos. 13, 14, 15, 16 and 17 to boundary stone No. 1 which is the point of commencement.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

I, the Governor, in exercise of the powers conferred by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1945, do hereby declare the erection of a Public Secondary School at Nicosia, with a boarding house annexed to it, to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Chairman of the Nicosia Town Committee for Greek-Orthodox Schools, in his capacity as Chairman of the Governing Body of the Greek-Orthodox Secondary Schools in the town of Nicosia, the supervision and effectuation of the said undertaking.

THE BURIALS LAWS, 1896 AND 1937.
