

No. 30. THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1945.**ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1945, I hereby order as follows :—

1. This Order may be cited as the Defence (Licensing of Certain Goods) Continuance of Licences Order, 1946, and shall be read in conjunction with the Defence (Licensing of Certain Goods) Order, 1943 (hereinafter in this Order referred to as "the principal Order").

Notwithstanding anything contained in the principal Order every licence issued or renewed under such Order during the year 1945 shall, unless cancelled in the meantime under the provisions of clause 5 thereof, continue to be valid and effective without renewal until the 31st day of December, 1946, subject to the same terms, limitations or conditions as there may be contained in such licence.

3. This Order shall be deemed to have been made on, and to have taken effect as from, the 1st day of January, 1946.

No. 32.**THE DEFENCE REGULATIONS, 1940 TO (No. 4) 1945.****ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 4) 1945, I hereby order as follows :—

1. This Order may be cited as the Defence (Medical Supplies) (Amendment) Order, 1946, and shall be read as one with the Defence (Medical Supplies) Orders, 1943 and 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Medical Supplies) Orders, 1943 to 1946.

2. Clause 7 of the principal Order is hereby deleted.

3. The principal Order is hereby amended by the insertion therein immediately after clause 5 of the following clause :—

"5A.—(1) Notwithstanding anything in clauses 4 and 5 of this Order contained, the Controller or a Deputy Controller may grant a permit to any person, not being a chemist and druggist or village retailer, to import, deal with, sell or have in his possession or under his control medical supplies ;

- (2) A permit issued under sub-clause (1) hereof may contain such terms, limitations and conditions as may be specified therein;
- (3) Subject to any term or condition contained in a permit granted under this clause, the provisions of this Order shall apply, *mutatis mutandis*, to any person to whom a permit has been granted under this clause as they apply to other persons who are registered importers under the provisions of this Order."
4. Clause 28 of the principal Order is hereby amended as follows:—
- (a) by the deletion therefrom of paragraph (g) of sub-clause 2 and the substitution therein of the following paragraph—
- “(g) insecticides other than Dichlorodiphenyltrichloroethane insecticides (commonly known as D.D.T. insecticides)”;
- (b) by the insertion therein of the following sub-clause (3)—
- “(3) For the purposes of this clause the word “Insecticides” means any liquid or powder used as a fly spray, whether branded or not, and includes diluted ready made preparations of Dichlorodiphenyltrichloroethane (commonly known as D.D.T.) solely for agricultural, or horticultural, or veterinary purposes or moth killers”.
