THE LAND ACQUISITION LAWS, 1899 TO 1946.

NOTICE UNDER SECTION 5.

Notice is hereby given that the lands described below are required by the Governor for an undertaking of public utility. Any person claiming to have any right or interest in the said lands is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.
