No. 39. THE OUTLAWS' PROCLAMATION LAW, 1946.

#### A PROCLAMATION.

By the Acting Governor.

Whereas a certificate issued under the provisions of section 3 of the Outlaws' Proclamation Law, 1946, has been received certifying that Djemal Mehmet Mita of Vrecha has been declared, under the provisions of the said section, to be an outlaw;

Now, therefore, in exercise of the powers vested in the Governor by section 4 of the Outlaws' Proclamation Law, 1946, I, Roland Evelyn Turnbull, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and state that the aforementioned Djemal Mehmet Mita of Vrecha has been declared to be an outlaw and I do require him, the said Djemal Mehmet Mita of Vrecha to surrender himself into the custody of the Police at any place in the Colony not later than the 23rd day of February, 1946, and do hereby further proclaim and state that, if the said Djemal Mehmet Mita of Vrecha fails so to surrender himself, a portion of his movable and immovable property may be forfeited under the provisions of the Outlaws' Proclamation Law. 1946.

This Proclamation shall continue in force until it is revoked or until the said Djemal Mehmet Mita of Vrecha surrenders himself or is arrested or until he is proved to have died.

#### A PROCLAMATION.

Whereas a certificate issued under the provisions of section 3 of the Outlaws' Proclamation Law, 1946, has been received certifying that Xenophon Panayi of Livadhi has been declared, under the provisions of the said section, to be an outlaw;

Now, therefore, in exercise of the powers vested in the Governor by section 4 of the Outlaws' Proclamation Law, 1946, I, Roland Evelyn Turnbull, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and state that the aforementioned Xenophon Panayi of Livadhi has been declared to be an outlaw and I do require him, the said Xenophon Panayi of Livadhi to surrender himself into the custody of the Police at any place in the Colony not later than the 23rd day of February, 1946, and do hereby further proclaim and state that, if the said Xenophon Panayi of Livadhi fails so to surrender himself, a portion of his movable and immovable property may be forfeited under the provisions of the Outlaws' Proclamation Law, 1946.

This Proclamation shall continue in force until it is revoked or until the said Xenophon Panayi of Livadhi surrenders himself or is arrested or until he is proved to have died.

## A PROCLAMATION.

Whereas a certificate issued under the provisions of section 3 of the Outlaws' Proclamation Law, 1946, has been received certifying that Georghios Themistokli of Panayia has been declared, under the provisions of the said section, to be an outlaw;

Now, therefore, in exercise of the powers vested in the Governor by section 4 of the Outlaws' Proclamation Law, 1946, I, Roland Evelyn Turnbull, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and state that the aforementioned Georghios Themistokli of Panayia has been declared to be an outlaw and I do require him, the said Georghios Themistokli of Panayia to surrender himself into the custody of the Police at any place in the Colony not later than the 23rd day of February, 1946, and do hereby further proclaim and state that, if the said Georghios Themistokli of Panayia fails so to surrender himself, a portion of his movable and immovable property may be forfeited under the provisions of the Outlaws' Proclamation Law, 1946.

This Proclamation shall continue in force until it is revoked or until the said Georghios Themistokli of Panayia surrenders himself or is arrested or until he is proved to have died.
