A PROCLAMATION.

BY THE ACTING GOVERNOR.

Whereas a certificate issued under the provisions of section 3 of the Outlaws' Proclamation Law, 1946, has been received certifying that Elias Georghiou Ornitharis of Kato Akourdhalia has been declared, under the provisions of the said section, to be an outlaw ;

Now, therefore, in exercise of the powers vested in the Governor by section 4 of the Outlaws' Proclamation Law, 1946, I, Roland Evelyn Turnbull, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and state that the aforementioned Elias Georghiou Ornitharis of Kato Akourdhalia has been declared to be an outlaw and I do require him, the said Elias Georghiou Ornitharis of Kato Akourdhalia to surrender himself into the custody of the Police at any place in the Colony not later than the 23rd day of February, 1946, and do hereby further proclaim and state that, if the said Elias Georghiou Ornitharis of Kato Akourdhalia fails so to surrender himself, a portion of his movable and immovable property may be forfeited under the provisions of the Outlaws' Proclamation Law, 1946.

This Proclamation shall continue in force until it is revoked or until the said Elias Georghiou Ornitharis of Kato Akourdhalia surrenders himself or is arrested or until he is proved to have died.

Given at Nicosia, this 10th day of February, 1946.

Now, therefore, in exercise of the powers vested in the Governor by section 4 of the Outlaws' Proclamation Law, 1946, I, Roland Evelyn Turnbull, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim and state that the aforementioned

Constantinos Demitri of Kelokedhara has been declared to be an outlaw and I do require him, the said Constantinos Demitri of Kelokedhara to surrender himself into the custody of the Police at any place in the Colony not later than the 23rd day of February, 1946, and do hereby further proclaim and state that, if the said Constantinos Demitri of Kelokedhara fails so to surrender himself, a portion of his movable and immovable property may be forfeited under the provisions of the Outlaws' Proclamation Law, 1946.

This Proclamation shall continue in force until it is revoked or until the said Constantinos Demitri of Kelokedhara surrenders himself or is arrested or until he is proved to have died.
