#### No. 48. THE POST OFFICE LAWS, 1881 TO 1933.

### ORDER IN COUNCIL No. 2181 MADE UNDER SECTION 6.

Acting Governor.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 6 of the Post Office Laws, 1881 to 1933, do hereby order as follows :-

1. This Order may be cited as the Parcels Post (Rates of Postage) (Amendment) Order, 1946, and shall be read as one with the Parcels Post (Rates of Postage) Orders, 1944 to (No. 3) 1945 (hereinafter referred Gazettes: to as "the principal Order "), and the principal Order and this Order Supplement may together be cited as the Parcels Post (Rates of Postage) Orders, 1944 to 1946.
