(CYPRUS) ORDER, 1946.

REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows :----

This Order may be cited as the Defence (Flour Milling) Order, 1946.
In this Order—

"mixed wheat and barley" means wheat and barley mixed in the proportion of 70% wheat and 30% barley.

"wheat and barley flour" means the ground products of mixed wheat and barley in the proportion of 70% wheat and 30% barley, with no more than 15% and not less than 12% of the bran having been extracted therefrom and free from any other cereals, foreign matter or added bran.

3. From and after the publication of this Order in the *Gazette* no wheat and barley other than mixed wheat and barley shall be ground at any mill save under a written permit issued by me.

4. No miller shall, save under a written permit issued by me, have in his possession or under his control or keep or allow or suffer to be kept in his mill any wheat and barley other than mixed wheat and barley.

5. Every permit issued under the provisions of clause 3 or 4 of this Order may contain such terms and conditions as I may deem fit to impose.

6. Save under a written permit issued by me, no miller shall—

(a) sift or permit or suffer to be sifted in his mill any ground product;(b) use or work in his mill for the grinding of mixed wheat and barley any machine known as "rollers".

7. Every miller shall keep in his mill a book in which he shall enter or cause to be entered at the end of each day the particulars set out in the First Schedule to this Order.

8. Not later than six days after the last day of each month, commencing from the month of April, 1946, every miller shall complete and deliver to me a return in the form of, and containing the particulars set out in, the Second Schedule to this Order.

9. Every miller shall permit such person as I, or the Commissioner of the district in which his mill is situated, may authorize in writing in that behalf, to enter upon his mill and make—

(a) such enquiries or inspection therein ; and

- (b) such inspection of any book kept under clause 7 of this Order, as may be necessary for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.
- 10. Any person who-

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order;
- (b) makes in any book kept under clause 7 of this Order any entry which is false in any material particular;
- (c) acts in contravention of, or fails to comply with, any term or condition contained in any permit issued under this Order;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order;

is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.
