**THE FOREST LAW, 1939.**

**ORDER IN COUNCIL No. 2265**

**MADE UNDER SECTION 3.**

**WINSTER,**

*Governor.*

In exercise of the powers vested in me by section 3 of the Forest Law, 1939, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1947, and shall be read as one with the Minor State Forests (Famagusta) Orders, 1943 to (No. 2) 1946, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1947.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of the areas Nos. 2 and 10 (relating to the villages of Avgorou and Kondea, respectively) and the substitution therefor of the following areas, respectively:—

" 2. Avgorou in the District of Famagusta :

(i) A portion of the crown land of sheet XLII, plan No. 1 E. & W. at the locality 'Andriou', demarcated by boundary stones numbered consecutively from 1 to 11, inclusive, comprising 20 donums approximately and shown on the Government Survey Plan Serial No. 1366, delineated thereon in green and marked 'A'.

(ii) A portion of the crown land of sheet XLII, plan No. 1 E. & W. at the localities 'Kamini Andriou' and 'Ayios Andreas', demarcated by boundary stones numbered consecutively from 1 to 34, inclusive, comprising 54 donums and 2 evleks approximately but excluding plots 182, 183 and 184 and shown on the Government Survey Plan Serial No. 1366, delineated thereon in green and marked 'B'.

(iii) A portion of the crown land of sheet XLII, plan No. 1 E. & W. at the locality 'Kamini Kampanolakkos', demarcated by boundary stones numbered consecutively from 1 to 17, inclusive, comprising 57 donums and 3 evleks approximately and shown on the Government Survey Plan Serial No. 1366, delineated thereon in green and marked 'C'.

10. Kondea in the District of Famagusta :

(i) A portion of Kouklia Reservoir at the locality 'Shiromandra', demarcated by boundary stones numbered consecutively from X6165 to X6173, comprising 16 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1283.

(ii) A portion of the crown land of sheet XXXII, plan No. 4 E. & W. at the locality 'Landa-Makria', demarcated by boundary stones numbered consecutively from 1 to 12, inclusive, comprising 26 donums and 3 evleks approximately and shown on the Government Survey Plan Serial No. 1367, delineated thereon in green."

**No. 317. THE FOREST REGULATIONS, 1940 TO 1944.**

NOTICE UNDER REGULATION 6.

It is hereby notified for general information that in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940 to 1944, His Excellency the Governor has been pleased to declare that the Minor State Forests, the areas of which are set out in the Schedule to the Minor State Forests (Famagusta) Orders, 1943 to 1947, as may be amended at any time, shall be reserved as Village Fuel Areas, with the exception of any such areas which are situated within the lands of villages having a municipal corporation which shall be reserved as Municipal Fuel Areas.

**No. 318. THE FOREST REGULATIONS, 1940 TO 1944.**

ORDER MADE UNDER REGULATIONS 8 (1) AND 8A.

WINSTER,  
*Governor.*

In exercise of the powers vested in me by regulations 8 (1) and 8A of the Forest Regulations, 1940 to 1944, I, the Governor, do hereby direct that—

- (a) the Village Fuel Areas and Municipal Fuel Areas reserved under Notification No. 317 published in Supplement No. 3 to the *Gazette* of the 23rd October, 1947; and
- (b) the Funds established or to be established in respect of the said Village Fuel Areas and Municipal Fuel Areas, respectively, in accordance with the provisions of regulation 12 of the Forest Regulations, 1940 to 1944,

shall be under the control of the Village Commission or the Council of the Municipal Corporation, as the case may be, of the village within the lands of which every such area is situate, respectively.

2. The Order published in Supplement No. 3 to the *Gazette* of the 7th January, 1943, under Notification No. 3, is hereby repealed without prejudice to anything done thereunder.
