THE TRADES AND INDUSTRIES (REGULATION) LAWS,  
1937 AND 1942.

ORDER IN COUNCIL No. 2231

MADE UNDER SECTION 4.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 4 of the Trades and Industries (Regulation) Laws, 1937 and 1942, do hereby order as follows:—

1. This Order may be cited as the Trades and Industries (Regulated Trades) Order, 1947.
2. Subject to the provisions of paragraph 3 hereof—
  - (a) the trades and industries set out in Part I of the Schedule hereto are hereby declared to be regulated trades for the purposes of the Law, if carried out within the limits of the municipality of Nicosia, Morphou, Lefka, Larnaca, Limassol, Famagusta, Paphos or Kyrenia;
  - (b) the trades and industries set out in Part II of the Schedule hereto are hereby declared to be regulated trades for the purposes of the Law whether carried out within the limits of the municipalities in paragraph 2 hereof mentioned or carried on in any district, sub-district, area, town, village, quarter or place in the Colony.
3. Nothing in this Order shall apply to any trade or industry carried on in connection with any mining operations by the holder of a mining lease or a prospecting permit.
4. This Order shall come into operation on the 15th day of September, 1947, and, thereupon, the Trades and Industries (Regulated Trades) Orders, 1937 to 1944, shall be revoked.

## PART I.

1. Carpentry shops in which any person excluding the owner or the person in charge thereof and members of his family is employed.
2. Cheese factories.
3. Coppersmiths shops.

15. Tailoring establishments in which any person excluding the owner or the person in charge thereof and members of his family is employed.
16. Tanneries.
17. Tinsmiths shops.

1. Aerated water factories.
2. Artificial teeth factories.
3. Boot-cream factories.
4. Breweries.
5. Canning and jam-making factories.
6. Establishments employing power-driven machinery.
7. Ice factories.
8. Gypsum factories.
9. Macaroni factories.
10. Oxy-acetylene welding establishments.
11. Paint factories.
12. Printing establishments.
13. Saw-mills.
14. Soap factories.
15. Ship-building and ship repairing yards.
