NOTICE UNDER SECTION 5.

With reference to the Notification published under No. 109 in Supplement No. 3 to *Gazette* No. 3362 of 18th March, 1948, notice is hereby given that the following lands are required by the Governor

IRRIGATION DIVISION OF DHROUSHA.

Rules.

1. These rules may be cited as the Irrigation Division of Dhrousha Rules, 1948.

2. In these Rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Paphos;

"Committee" means the Committee of the Irrigation Division; "Irrigation Division" means the Irrigation Division of Phrougha:

"Law" means the Irrigation Divisions (Villages) Laws, 1938 and 1944;
