

NOTIFICATION UNDER SECTION 121.

Whereas the property described in the Schedule hereto is required by the Mayor, Deputy Mayor, Councillors and Townsmen of Famagusta (hereinafter referred to as "the Municipal Corporation") for the public purpose of erecting a municipal market within the municipal limits of Famagusta :

And whereas His Excellency the Governor has approved the plan submitted in that behalf, and considers it expedient, having regard to all the circumstances, that the Municipal Corporation should be permitted to acquire the said property for the above public purpose :

Now, therefore, in exercise of the powers vested in him by section 121 of the Municipal Corporations Laws, 1930 to 1945, His Excellency the Governor has been pleased to sanction and hereby sanctions the acquisition of the property described in the Schedule hereto by the Municipal Corporation.
