In exercise of the powers vested in him by section 9 (1) of the Trading with the Enemy Laws, 1939 to 1945, His Excellency the Governor has been pleased to appoint and hereby appoints Mr. Sidney Montague Rich, Assistant Treasurer, to be the Custodian of Enemy Property in the Colony as from the 24th May, 1948, in the place of Mr. Cecil James Thomas who has been granted leave of absence as from that date.

No. 238.**THE EMERGENCY POWERS (CYPRUS DEFENCE) (FINANCE) REGULATIONS, 1940 TO (No. 2) 1941.****NOTICE.**

It is hereby notified for general information that His Excellency the Governor has been pleased to appoint Mr. Sidney Montague Rich, Assistant Treasurer, with effect from the 24th May, 1948, to be "Exchange Officer" generally for the purposes of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1940 to (No. 2) 1941, and in particular to act on behalf of the Governor in respect of all or any of the following matters, that is to say,—

- (a) in the event of an order being made under regulation 3, to grant permissions thereunder and to be the person to whom returns should be made thereunder;
- (b) to grant permissions under regulation 5 (1);
- (c) to grant certificates under regulation 5 (2) and 5 (5);
- (d) to be the person designated for the purposes of regulations 6 and 7;
- (e) to give directions under regulation 11.

2. The arrangements made by Notification No. 398 published in Supplement No. 3 to the *Gazette* of the 12th December, 1946, are cancelled, and the appointment of Mr. Cecil James Thomas as "Exchange Officer" is terminated as from the 24th May, 1948.
