NOTICE UNDER SECTION 12.

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd from one village area to another, along any public road at any hour.

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

Rules made by the Village Health Commission of the Village of Milikouri under Section 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Milikouri hereby make the following rules:—

- 1. These rules may be cited as the Village Health (Milikouri) Rules, 1948, and shall come into operation on their publication in the *Gazette*.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Karavostasi) Rules, 1938, published in the *Gazette* of the 4th March, 1938, shall—
 - (a) be deemed to be rules made by the Village Health Commission of Milikouri and to be incorporated herein, and

(b) apply to the village of Milikouri.

- (2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Karavostasi) Rules, 1938.
- (3) Those rules of the Village Health (Karavostasi) Rules, 1938, mentioned in Part II of the Schedule hereto, shall not apply to the village of Milikouri.
