In exercise of the powers vested in me by the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Colony by the Supplies and Services (Transitional Powers) (Colonies, etc.) Order in Council, 1946, I, the Governor, do hereby order as follows:—

- 1. These regulations may be cited as the Defence (Importation of Goods) Amendment Regulations, 1948, and shall be read as one with the Defence (Importation of Goods) Regulations, 1943 and 1947, mentioned in item 7 of the Second Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which have effect by virtue of the Act aforementioned (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence (Importation of Goods) Regulations, 1943 to 1948.
- 2. Regulation 3 of the principal Regulations is hereby amended by the insertion therein immediately after paragraph (b) of the following

(c) to any articles of food not exceeding 22 lbs. in weight consigned through the Postal Service to a private individual for

his private use ".

THE STREET AND HOUSE TO HOUSE COLLECTIONS LAW, 1948.

REGULATIONS MADE UNDER SECTION 5.

WINSTER,

Governor.

In exercise of the powers vested in me by section 5 of the Street and House to House Collections Law, 1948, I, the Governor, do hereby make the following regulations:

- 1. These regulations may be cited as the Street and House to House Collections Regulations, 1948, and shall come into force on the 28th October, 1948.
- 2. Every application to promote a collection shall be as in Form I in the Schedule hereto; it shall contain true and accurate information on the particulars therein set out and shall not be considered, unless made not less than twenty days before the date on which it is proposed to make the collection.
- 3. Every licence granted for the promotion of a collection shall be as in Form II in the Schedule hereto and shall be subject to such terms and conditions as may be imposed by the Licensing Authority regarding the matters therein set out and to such further terms and conditions as the Licensing Authority may think fit to impose.

- 4.—(1) No collector shall make or engage in a collection, unless—
 - (a) he is in possession of a certificate of authority as in Form III in the Schedule hereto, containing the particulars therein set out and duly signed by the promoter; and
 - (b) he wears the badge approved in connection with the collection.
- (2) No promoter shall permit any person to act as a collector unless he has issued to that person an approved badge and a certificate of authority as in paragraph (1) of this regulation provided; and the promoter shall exercise due care and diligence to secure that every badge and certificate of authority issued by him is returned when the collection is completed or for any other reason the collector ceases to act as such.
- 5. If no box or other receptacle is to be used for a collection, the collector shall give a receipt duly stamped and signed by him in respect of all moneys collected.
- 6. Every collector shall ensure that all money collected is accounted for to the promoter.
- 7.—(1) Every promoter shall keep a true and accurate account of the proceeds of the collection and of all disbursements therefrom and shall furnish a copy thereof to the Licensing Authority not later than ten days after the completion of the collection:

Provided that the Licensing Authority may extend the period if satisfied that there are special reasons for so doing.

- (2) The Licensing Authority may give or require the promoter to give such publicity to the statement of accounts as they may think fit and the promoter shall be bound to give such publicity accordingly.
- 8. When boxes or other receptacles are used for a collection, the promoter shall open the boxes or receptacles in the presence of the collector concerned and shall sign and hand to him a receipt showing the amount contained in such box or receptacle.
 - 9. No person shall act as a collector who is under fifteen years of age.
- 10.—(1) No person shall, in relation to, or in connection with, any collection—
 - (a) intimidate or in any way, directly or indirectly, exercise any pressure on, or annoyance to, any other person;
 - (b) obstruct or interfere in any way with the traffic or persons using the streets or public places.
- (2) For the purposes of this regulation, a person shall be deemed to have exercised pressure on, or annoyance to, any other person if he takes, attempts or pretends to take down the name or otherwise record or mark the identity, of any person who declines or is unwilling to make any donation.
- 11. Every collector shall, upon the demand of a police officer in uniform or by any occupant of a house visited or person solicited, produce to him his certificate of authority.
- 12. Any person, who contravenes or fails to comply with the provisions of any of these regulations or with any term or condition imposed in any licence granted by the Licensing Authority, is guilty of an offence under sections 5 and 9 of the Street and House to House Collections Law, 1948.
