

No. 404. THE IMMIGRATION LAWS, 1936 TO 1947.**ORDER MADE BY THE GOVERNOR UNDER SECTION 8 (3).**

In exercise of the powers vested in me by section 8 (3) of the Immigration Laws, 1936 to 1947, I, the Governor, do by this Order direct that British Consular visas be dispensed with in the case of any person landing at an airport in the Colony in transit for another country if such person is in possession of a ticket for his onward journey and a visa for the country of his destination :

Provided that no such person shall leave the airport unless he obtains permission from an immigration officer to enter the Colony containing such terms and conditions as such immigration officer may, subject to any general or special directions of the Principal Immigration Officer, think fit to attach.

No. 405. THE INCREASE OF RENT (RESTRICTION) LAWS, 1942 TO 1947.**NOTIFICATION UNDER SECTION 4.**

In exercise of the powers vested in me by section 4 of the Increase of Rent (Restriction) Laws, 1942 to 1947, and of every other power thereunto enabling and notwithstanding anything contained in the Notification published in Supplement No. 3 to the *Gazette* of the 4th September, 1947, under No. 257 (hereinafter referred to as "the principal Notification"), I, the Governor, do hereby appoint Mr. Euripides Themistos, Acting District Judge, to perform the duties of Mr. Lefkios Zenon, District Judge (who is absent on leave) as President of the Rent Assessment Boards in the Rent Restriction Areas of Famagusta, Kyrenia, Larnaca, Limassol, Nicosia and Paphos, in lieu of Mr. Costakis E. Glykys, District Judge, as mentioned in the proviso to paragraph 1 (b) of the principal Notification.

2. This Notification shall be valid and operative until the 13th December, 1948, but, subject to this, the principal Notification shall be valid and operative as if the present Notification had not been made.
