# THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rule's made by the Village Health Commission of Milea, in the District of Famagusta, and approved by the Commissioner, are published in the *Gazette*.

## RULES MADE BY THE VILLAGE HEALTH COMMISSION OF MILEA UNDER SECTION 9.

In exercise of the powers vested in them under section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Milea hereby make the following rules :---

1. These rules may be cited as the Village Health (Milea) (Amendment) Rules, 1948, and shall be read as one with the Village Health (Milea) Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Milea) Rules, 1938 to 1948.

2. Rule 20 of the principal Rules is hereby repealed and the following rule substituted therefor :---

"Rule 20.—The following fees shall be paid to the Inspector by the owner or the person slaughtering any animal in the slaughter-house :—

# THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Kalopanayiotis and Oekos, in the District of Nicosia, are published in the *Gazette*.

### IRRIGATION DIVISION OF KALOPANAYIOTIS AND OEKOS.

#### Rules.

These rules may be cited as the Irrigation Division of Kalopanayiotis and Oekos (Amendment) Rules, 1948, and shall be read as one with the Irrigation Division of Kalopanayiotis and Oekos Rules, 1933 and 1947 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Kalopanayiotis and Oekos Rules, 1933 and 1948.

2. Rule 4(c) of the principal Rules is hereby amended by the deletion therefrom of the words "The Treasurer shall be unpaid" and the substitution therefor of the words "The Treasurer shall receive a remuneration of three per cent of all rates and charges collected by him as provided in section 4 (1) of this rule".
