With reference to the Notification published under No. 215 in Supplement No. 3 to *Gazette* No. 3376 of 11th June, 1948, notice is hereby given that the following land is required by the Governor for the undertaking of public utility mentioned therein :

Notice is hereby given that the following lands are required by the Governor for an undertaking of public utility :—

All those areas of land, with the trees and buildings thereon, situated in the Town of Limassol, comprising  $20\frac{1}{2}$  donums or thereabouts and including part of plots Nos. 144/1, 143, 142, 202 of the Government Survey Plan No. LIV.57, part of plots Nos. 28, 29, 9/3, 35/1, 37, 74, 78/1, 83/3, 84/3/2, 84/4, 85/3/1, 90/1, 90/2, 87, 89, 88/6/2, 106/2, 107/2, 109/3/1, 109/3/2, 114, 116, and the whole of plots Nos. 84/2/1 and 85/2/2 of the Government Survey Plan No. LIV.58, more particularly defined as the areas coloured red on the plan marked "Part of Limassol Bye-Pass" and dated 6th September, 1948, deposited with the Commissioner of Limassol.
