

COMPULSORY ACQUISITION ORDER.

THE ANTIQUITIES LAWS, 1935 AND 1945—(Section 12)

AND
THE LAND ACQUISITION LAWS, 1899 TO 1947.

Whereas His Excellency the Acting Governor is satisfied that in order to preserve the amenities of the Abbey of Bellapais, an ancient monument set out as item 5 in the Kyrenia District, in the First Schedule of the Antiquities Laws, 1935 and 1945, it is desirable that no building should be erected in the proximity of such ancient monument upon the plots of land described in the Schedule hereto and that any buildings thereon should be demolished;

Now, therefore, in exercise of the powers vested in the Governor by section 12 of the Antiquities Laws, 1935 and 1945, His Excellency the Acting Governor is pleased to direct and hereby directs that the properties described in the Schedule hereto be acquired on payment of such amount by way of compensation as may be agreed upon between the Commissioner of Kyrenia and the proprietors thereof and that in default of agreement within one month from the date hereof the amount of compensation be determined in accordance with the provisions of the Land Acquisition Laws, 1899 to 1947.
