THE DEFENCE (IMPORTATION OF GOODS) REGULATIONS, 1943 TO 1948.

OPEN GENERAL IMPORT LICENCE No. C136700.

In exercise of the powers vested in me by virtue of the Defence (Importation of Goods) Regulations, 1943 to 1948, I hereby grant to any importer registered under the provisions of the Defence (Control of Sale Prices of Imported Articles) Orders, 1943 to 1948, an Open General Import Licence under No. C136700 to import into the Colony in any quantity any goods originating in the United Kingdom, and supplied from the United Kingdom (but not goods supplied from other territories through the United Kingdom and/or imported in the United Kingdom), provided that the goods imported shall not include any of the commodities in the Schedule hereinbelow, and provided that in all cases payment shall be made in sterling.

This Open General Import Licence is deemed to be a written licence issued by me under regulation 2 (1) (a) of the Defence (Importation of Goods) Regulations, 1943 to 1948, and is subject to the provisions of regulation 2 (b) of the said Regulations.

SCHEDULE.

1. Cereals, including wheat, barley, oats, rye, maize, millet, flour of all kinds and bran of all kinds.
2. Cereal products of all kinds, including cereal filler, oat products, macaroni, semolina and breakfast cereals.
3. Beans, peas, lentils and pulses of all kinds, whether canned, dry or otherwise.
4. Rice, whole and broken, and all rice products, including rice starch and flour.
5. Fodder for cattle and all animal feeding stuffs, including oil cakes and meals of all types and mixed feed.
6. Meat, tinned or otherwise.

8. Butter substitutes and fats of all kinds.

9. Cheese ; common and fine.
10. Milk ; condensed and powder.
11. Milk-based infant foods.
12. Dried fruits.
13. Whisky.
14. Glucose.
15. Molasses.
16. Oils of all kinds, edible and non-edible.
17. Sugar.
18. Cocoa beans.
19. Coffee, raw, roasted or ground.
20. Fruit juices.
21. Manufactured tobacco : cigarettes, pipe tobacco.
22. Charcoal.
23. Coal.
24. Seeds and seed potatoes.
25. Sulphur.
26. Timber of all kinds, whether ready cut or otherwise.
27. Coke and manufactured fuel.
28. Glass, plate and sheet.
29. Cement.
30. Iron and steel and manufactures thereof :—
 - (a) Pig iron ;
 - (b) Bars, joists, rods, plates, sheets, tubes and pipes, including galvanized ;
 - (c) Fittings for tubes and pipes ;
 - (d) Wire and wire rope of all kinds.
31. Lead, semi-manufactures.
32. Tin bars and ingots and tin plate.
33. Cutlery.
34. Engines, pumps, windmills, machinery and spare parts.
35. Cotton yarn.
36. Cotton linings and poplin.
37. Knitted woollen garments made of cashmere, mohair, camel-hair, llama and vicuna.
38. Women's and girls' wool stockings.
39. Boots and shoes.
40. Caustic soda.
41. Soda ash.
42. Manures, chemical.
43. Streptomycin and preparations of streptomycin.
44. Petroleum, crude.
45. Lubricating oils.
46. Petrol and benzine.
47. Petroleum (kerosene).
