A PROCLAMATION.

WINSTER,
Governor.

In exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Reginald Thomas Herbert, Baron Winster of Witherslack, Privy Counsellor, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 15th day of February, 1948 :—

1. The boundary of the Town of Nicosia shall be as set forth in Schedule A hereof.
2. The Town of Nicosia comprised within the boundary aforesaid shall be divided into the quarters set forth in Schedule B hereof.
3. The Proclamation made by His Excellency the Governor dated the 5th October, 1943, and published under Notification No. 351 in Supplement No. 3 to *Gazette* No. 3076 of the 7th October, 1943, as amended by subsequent Proclamations, shall be revoked.

SCHEDULE A.

Boundary of the Town of Nicosia.

The boundary commences on the south-western side of the main road from Nicosia to Kyrenia where it is crossed by the road from the tannery near the Golf Course to the village of Trakhonas, and proceeds north-eastwards along the western side of the latter road to a point due west of the north-western corner of plot No. 15 of Block A, Trakhonas village; thence eastwards along the northern boundary of the said plot to its north-eastern corner on the main road from the village of Trakhonas to Nicosia; thence south-eastwards for a distance of 100 feet approximately along the said road to the north-western corner of plot No. 16 of Block A, Trakhonas village; thence eastwards and southwards along the northern and eastern boundaries of the said plot and the northern boundary of plot No. 17 of the said Block to the north-eastern corner of the said plot; thence southwards, eastwards and southwards following the boundaries of and including plots Nos. 17, 19, 21, 27 and 40 to the point where the northern side of the by-pass cuts the eastern boundary of plot No. 40 of the Ibrahim Pasha Quarter, Block A of the Government Survey Plan No. XXI.38.2.IV; thence eastwards along the northern side of the said by-pass to the south-western corner of plot No. 102 of Block B, Omorphita village, of the Government Survey Plan No. XXI.38.3.IV,

which corner is on the eastern side of the road leading from the Government Railway Stores to the new Turkish Cemetery ; thence southwards along the said road to the south-western corner of plot No. 88 of Block B, Omorphita village, of the Government Survey Plan No. XXI.38.6.II; thence eastwards along the boundaries of but excluding plots Nos. 88 and 148 of the said Block to the south-eastern corner of the last mentioned plot, which corner is on the western side of a road ; thence northwards along the said road to a point where a new road branches off ; thence eastwards along the northern side of the said road to the eastern side of the road leading from Nicosia to the village of Omorphita ; thence south-westwards along the eastern side of the said road to the most northern point of plot No. 76 of the said Block and plan ; thence southwards and eastwards along the boundaries of and including plots Nos. 76, 71, 70 and 69 of the said Block and plan, plot No. 68 of the said Block of the Government Survey Plan No. XXI.39.4.I to the eastern side of the road leading from the village of Palouriotissa to the village of Omorphita ; thence southwards along the said side of the road to the point where the southern side of the railway line crosses the said road ; thence south-eastwards along the eastern side of the said road to the cross-roads at the most northern point of plot No. 40 of Block A, Palouriotissa village ; thence south-westwards along the eastern side of the road from the village of Beuyuk Kaimakli to the Famagusta Gate of Nicosia to the junction of roads at the south-western corner of plot No. 137 of Block A, Palouriotissa village ; thence southwards along the eastern side of the road leading to the main road from Nicosia to Kythrea to the south-western corner of plot No. 62 of the said Block ; thence south-eastwards in a straight line to the most northern point of the Turkish Cemetery (plot No. 4 of Block 23, Taht-el-Kale Quarter) ; thence south-westwards along the eastern side of the said Turkish Cemetery to the main road from the Famagusta Gate of Nicosia to Larnaca ; thence south-eastwards along the northern side of the said main road to the cross-roads at the most northern point of plot No. 24 of Block D, Palouriotissa village ; thence southwards along the eastern side of the road to the Isolation Hospital, to the north-western corner of plot No. 95 of Block D, Palouriotissa village ; thence westwards along the southern side of the road leading to the main road from Ayios Antonios School to Larnaca ; thence south-eastwards along the eastern side of the said main road to the cross-roads at the north-eastern corner of the Mental Hospital ; thence westwards along the southern side of the road bounding the said hospital to the main road from the old Nicosia Greek Cemetery to Larnaca ; thence south-eastwards along the eastern side of the said main road to the north-eastern corner of the Nicosia Greek Community Orphanage (plot No. 233 of Block B, Ayii Omoloyitadhes village) ; thence westwards along the southern boundary of the road from Ayia Paraskevi to the village of Ayii Omoloyitadhes to the most northern corner of plot No. 62 of Block B, Ayii Omoloyitadhes village, of the Government Survey Plan No. XXI.54.2.IV at the fork roads ; thence southwards along the eastern side of the road to the cross-roads at the most northern corner of plot No. 215 of the said Block of the Government Survey Plan No. XXI.54.5.IV ; thence south-westwards along the road to the fork roads at the most western corner of the said plot ; thence north-westwards along the southern side of the road to the road junction at the most northern corner of plot No. 172 of Block D, Ayii Omoloyitadhes village, of the Government Survey Plan No. XXI.54.W.2 ; thence southwards along the eastern side of the road to the most western corner of plot No. 175 of the said Block and plan ; thence north-westwards along the road to the most southern corner of plot No. 27 of the said Block and plan ; thence in the said direction to the most western corner of the said plot ; thence south-

westwards to the most southern corner of plot No. 139 of the said Block and plan; thence north-westwards along the southern side of the said plot to its most western corner on the main road from the village of Palouriotissa to the village of Strovolos; thence south-westwards along the eastern side of the said main road to the Strovolos bridge, on the boundary of the village of Strovolos; thence northwards along the said village boundary and along the boundary of the village of Engomi (including the roads where the village boundaries follow roads) to the north-eastern corner of plot No. 83 of Block B, Engomi village, on a track; thence westwards along the southern side of the said track to the main road from Nicosia-Troodos road bridge to the village of Engomi; thence south-westwards along the western side of the said main road to the most southern point of plot No. 186 of Block C, Engomi village, on a track; thence westwards along the southern side of the said track, (crossing a road from the Nicosia-Troodos road to Kykko Monastery) to the south-western corner of plot No. 207 of Block C, Engomi village; thence northwards along the boundaries of and including plots Nos. 207, 205, 204, 201, 200 and 194 of the said Block to the north-western corner of the last mentioned plot and on the main road from Nicosia to Troodos; thence westwards along the said main road in a straight line to the south-eastern corner of plot No. 71 of Block Q, Ayios Dhometios village, at a junction of roads; thence northwards along the western side of the road leading to the north-eastern corner of plot No. 69 of the said Block on the main road from Nicosia to Myrtou; thence westwards along the said main road to the south-eastern corner of plot No. 80 of Block N, Ayios Dhometios village, at a junction of roads; thence northwards along the western side of the road leading to the most northern point of plot No. 89 of the said Block, at a junction of roads; thence north-eastwards along the northern side of the road leading to the south-eastern corner of plot No. 126 of the said Block at a junction of roads; thence northwards along the western side of the road leading to the junction of roads at the north-eastern corner of plot No. 133 of Block N, Ayios Dhometios village; thence north-westwards along the southern side of the road leading to the cross-roads at the south-eastern corner of plot No. 164 of Block B, Ayios Dhometios village; thence northwards along the western side of a road to the south-eastern corner of plot No. 53 of Block H, Ayios Dhometios village, at a cross-roads; thence eastwards along the northern side of a road to the cross-roads at the south-eastern corner of plot No. 51 of the said Block; thence northwards and north-eastwards along the western and northern side of a road to the most southern corner of plot No. 3 of Block K, Ayios Dhometios village; thence northwards along the western boundary of the said plot to the road forming the southern boundary of the Nicosia Golf Course; thence eastwards along the northern side of the said road to the right bank of the River Pedieos; thence northwards along the said bank to the Cyprus Government Railway Bridge; thence eastwards along the southern side of the said Railway to the western side of the road from the tannery near the Golf Course to the village of Trakhonas; thence north-eastwards along the western side of the said road to the point of commencement, all which said boundary is hatched in black on the Government Survey Plan Serial No. 1384.

SCHEDULE B.

Quarters of the Town of Nicosia.

1. The quarters Arab Ahmed Pasha, Mahmout Pasha, Ak Kavouk, Ayios Loukas, Abdi Chavoush, Yeni Jami, Iplik Bazari and Korkout Effendi, Ayia Sophia, Haidar Pasha, Ayios Kassianos, Khrysaliniotissa, Taht-el-Kale, Ayios Ioannis, Omerieh, Ayios Savvas, Phaneromeni, Tabak Khane, Nebet Khane, Karaman Zade, Ayios Andreas, Trypioti,

Ayios Antonios and Ayii Omoloyitadhes comprising respectively the properties which at the date of the commencement of this Proclamation are recorded in the books of the Land Registry Office as the properties comprised within the quarters aforesaid.

2. The Ibrahim Pasha quarter comprising :—

- (a) the properties which at the date of the commencement of this Proclamation are recorded in the books of the Land Registry Office as the properties comprised within the quarter aforesaid; and
- (b) the properties within the following boundary hitherto forming part of the village area of Omorphita, that is to say :—

The boundary commences at the point where the northern side of the by-pass cuts the eastern boundary of plot No. 40 of Ibrahim Pasha Quarter, Block A of the Government Survey Plan No. XXI.38.2.IV and proceeds eastwards along the northern side of the said by-pass to the south-western corner of plot No. 102 of Block B, Omorphita village, of the Government Survey Plan No. XXI.38.3.IV, which corner is on the eastern side of the road leading from the Government Railway Stores to the new Turkish cemetery; thence southwards along the said road to the south-western corner of plot No. 88 of Block B, Omorphita village, of the Government Survey plan No. XXI.38.6.II; thence eastwards along the boundaries of but excluding plots Nos. 88 and 148 of the said Block to the south-eastern corner of the last mentioned plot, which corner is on the western side of a road; thence northwards along the said road to a point where a new road branches off; thence eastwards along the northern side of the said road to the eastern side of the road leading from Nicosia to the village of Omorphita; thence south-westwards along the eastern side of the said road to the most northern point of plot No. 76 of the said Block and plan; thence southwards and eastwards along the boundaries of and including plots Nos. 76, 71, 70 and 69 of the said Block and plan, plot No. 68 of the said Block of the Government Survey Plan No. XXI.39.4.I to the eastern side of the road leading from the village of Palouriotissa to the village of Omorphita; thence southwards along the said side of the road to the point where the southern side of the railway line crosses the said road; thence south-westwards along the said side of the said railway to the north-western corner of plot No. 36 of Ibrahim Pasha Quarter, Block No. 28 of the Government Survey Plan No. XXI.38.6.IV, which point is on the south-eastern side of the road leading from Nicosia to the village of Omorphita; thence north-eastwards along the said road to its junction with another road which passes along the northern boundary of plot No. 240 of Ibrahim Pasha Quarter, Block A of the said plan; thence westwards along the said road to the south-western corner of plot No. 317 Block B, Omorphita village, of the Government Survey Plan No. XXI.38.6.I; thence northwards along the boundaries of and including plots Nos. 317, 314 and 14 of the said Block and plan, plots Nos. 13 and 122 of the said Block of the Government Survey Plan No. XXI.38.3.III to the point of commencement, all which said area is hatched in violet on the Government Survey Plan Serial No. 1384.
