No.56. THE LAND ACQUISITION LAWS, 1899 TO 1947.

#### NOTICE UNDER SECTION 5.

With reference to the Notification published under No. 391 in Supplement No. 3 to the *Gazette* No. 3343 of 18th December, 1947, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned in that Notification :—

All those areas of land situated in the villages of Peristerona, Avlona and Philia in the District of Nicosia, comprising 16 donums or thereabouts, bounded on all sides by private property, and including part of plots Nos. 233/1, 229, 231, 351, 353 & 352, 461, 462 of the Government Survey Plan No. XX.60, part of old plot 401, part of plots Nos. 506, 505, 504, 501, 503, 502 of the Government Survey Plan No. XX.52, part of plots Nos. 198/1 & 198/2, plots 201/1 & 201/2, part of plot 200, part of old plots 123, 285, 125, 83, 76, 74, 72 of the Government Survey Plan No. XX.44, part of plots Nos. 629, 626, 625, 624 of the Government Survey Plan No. XX.36, more particularly defined as the areas coloured red on the plan marked "Part of the Peristerona–Avlona–Philia– Massari and Philia–Skylloura Road" and dated 8th January, 1948, deposited with the Commissioner, Nicosia.

THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Avlona, in the District of Nicosia, are published in the *Gazette*.

### IRRIGATION DIVISION OF AVLONA.

Rules.

1. These rules may be cited as the Irrigation Division of Avlona (Amendment) Rules, 1948, and shall be read as one with the Irrigation Division of Avlona Rules, 1932, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Avlona Rules, 1932 and 1948.

2. Paragraph (c) of rule 4 of the principal Rules is hereby deleted and the following paragraph is substituted therefor:

"(c)—The treasurer shall be paid—

(i) a remuneration of five per centum of all rates and charges collected by him as in paragraph (a) hereof;

(ii) such of his out of pocket expenses as may be sanctioned by the Committee."

## No. 58.

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1943.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF THE VILLAGE OF APSIOU UNDER SECTION 9.

In exercise of the powers vested in them by Section 9 of the Public Health (Villages) Laws, 1936 to 1943, the Village Health Commission of Apsiou hereby make the following rules :—

1. These rules may be cited as the Village Health (Apsiou) Rules, 1947, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Karavostasi) Rules, 1938, published in the *Gazette* of 4th March, 1938, shall—

(a) be deemed to be rules made by the Village Health Commission

of Apsiou and to be incorporated herein, and

(b) apply to the village of Apsiou.
