### A PROCLAMATION

# BY THE GOVERNOR.

In exercise of the powers vested in me by section 3 (2) of the Municipal Corporations Laws, 1930 to 1945, I, Reginald Thomas Herbert, Baron Winster of Witherslack, Privy Counsellor, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim the village of Athienou in the District of Larnaca a municipal corporation.

# THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

#### LIMITS OF THE MUNICIPAL CORPORATION OF ATHIENOU.

Notice under Section 6.

WINSTER,

Governor.

In exercise of the powers vested in me by section 6 of the Municipal Corporations Laws, 1930 to 1945, I, the Governor, do hereby declare that, upon the proclamation of the village of Athienou in the district of Larnaca as a municipal corporation, the municipal limits of such corporation shall be as set forth in the Schedule hereto.

## SCHEDULE.

# Municipal Boundary of Athienou.

The boundary commences at the north-eastern corner of Plot No. 600 of the Government Survey Plan No. XXXI.37, locality "Anephani-tou-Dromou-tou-Margou", which corner is on a footpath, and proceeds south-eastwards along the said footpath to the most western point of Plot No. 551 of the said plan; thence north-eastwards along the boundaries of and including Plots Nos. 551, 556 and 555 of the said plan, to the road leading from the village of Tymbou to the village of Athienou, locality Aspradhia"; thence northwards along the said road to the northwestern corner of Plot No. 522 of the said plan, locality "Arkodhaphja"; thence eastwards along the boundaries of and including Plots Nos. 522 521, 520, 517, 495, 496 and 492 of the said plan, to the road leading from the village of Tymbou to the village of Athienou, at the north-eastern corner of the last mentioned plot; thence southwards along the said road to the north-western corner of Plot No. 476 of the said plan, locality "Aspradhia"; thence eastwards along the boundaries of and including Plots Nos. 476, 480, 479, 470, 469, 459, 457, 456, 454, 452, 301, 423, 420, 417 428, 429 and 430 of the said plan, to the road leading from the village of Ayia to the village of Athienou, at the most eastern point of the last mentioned plot, locality "Katsokhirin"; thence north-eastwards along the said road, to the most northern point of Polt No. 402 of the said plan, locality "Lantin"; thence south eastwards along the boundaries of and including Plots Nos. 402, 401, 398, 394, 393, 740, 741, 746, 745 of the said plan, locality "Stena Laxidhia", Plots Nos. 169, 168, 167, 166, 163, 162, 189, 206, 210, 244 and 243 of the Government Survey Plan No. XXXI.45 to a footpath at the south-eastern corner of the last mentioned plot, locality "Muti-tis-Lenous"; thence westwards along the said footpath to the north-eastern corner of Plot No. 275 of the said plan; thence southwards along the boundaries of and including Plots Nos. 275, 276, 285, 284, 307, 586 and 584 of the said plan, to the road leading from the village of Athienou to Larnaca, at the southwestern corner of the last mentioned plot, locality "Phytorion"; thence south-eastwards along the said road to the junction of roads at the most southern point of Plot No. 649 of the said plan, locality "Kaphounta"; thence north-westwards along the road to the junction with a footpath at the north-eastern corner of Plot No. 578 of the said plan, locality "Kaminia"; thence south-westwards along the footpath to the southeastern corner of Plot No. 576 of the said plan; thence westwards along the boundaries of and including Plots Nos. 576, 575, 572, 560, 562, 548, 546, 338, 342, 343, 358, 365, 370, 386, 391, 390 and 410 of the said plan to the road leading from the village of Petrophani to the village of Athienou at the most western point of the last mentioned plot, locality ' Kolymbia '' ; thence north-eastwards along the said road to the southeastern corner of Plot No. 420 of the said plan; thence westwards and northwards along the boundaries of and including plots Nos. 420, 421, 452, 440, 441, 444, 443, 58, 57 and 59 of the said plan to the road leading from the village of Potamia to the village of Athienou, at the northwestern corner of the last mentioned plot, locality "Argakia"; thence westwards along the said road to the south-western corner of Plot No. 50 of the said plan; thence northwards along the boundaries of and including plots Nos. 50, 48, 47, 44, 39, 37, 2 and 1 of the said plan, Plots Nos. 593, 595, 596, 598, 599, 600 and 601 of the Government Survey Plan No. XXXI.37 to the point of commencement, all which said area is edged red on the Government Survey Plan Serial No. 1386.
