THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

NOTICE UNDER SECTION 3 (3).

WINSTER,

Governor.

Whereas by proclamation made on the 12th day of March, 1948, the village of Athienou in the District of Larnaca was proclaimed a municipal corporation ;

Now, therefore, in exercise of the powers vested in me by section 3 (3) of the Municipal Corporations Laws, 1930 to 1945, (hereinafter referred to as "the Laws"), I, the Governor, do hereby order and direct as follows :—

- 1.—(a) the persons whose names appear in the First Appendix hereto are nominated for the purposes of the election of the council of the said Municipal Corporation and for all other purposes as may be necessary for applying the Laws to the said Municipal Corporation ;
- (b) the times and places specified in the Second Appendix hereto shall be the times and places for the purposes of the election of the council of the said Municipal Corporation ;
- (c) the Commissioner of Larnaca shall, for the purposes of the election of the council of the said Municipal Corporation and for all other purposes as may be necessary for applying the said Laws to the said Municipal Corporation, have all the powers and authorities which belong to the Commissioner under the Laws and shall perform all the duties which are performed by the Commissioner under the Laws, with the additional power and authority to appoint such persons as may be necessary to assist in any matter to which this notice applies and to make advances of any money for any expenditure in connection therewith, such advances to be a charge on, and to be refunded out of, the Municipal Fund when the Fund begins to operate.

2. Words and expressions in this notice shall have the same meaning as the corresponding words and expressions in the Laws and, for the purposes of this notice, all the provisions of the Laws and of the First, Second, Third, Fourth and Fifth Schedules thereto, together with any forms therein set out, relevant to the purposes of this notice, shall apply with such variations as may be necessary for giving effect to this notice and to the proclamation and constitution of Athienou as a Municipal Corporation.

FIRST APPENDIX.

Nominations.

The following persons are nominated :—

- (a) Mr. Andreas Michael Hji Theochari of Athienou, who shall, until the council takes office, have all the powers and authorities which belong to a mayor under the Laws and perform all the duties which are performed by a mayor thereunder (in this notice referred to as "the Mayor") ;

- (b) Mr. Stephanis Costa Papapavlou of Athienou, who shall, until the council takes office, have all the powers and authorities which belong to a town clerk under the Laws and perform all the duties which are performed by a town clerk thereunder, (in this notice referred to as "the Town Clerk"), and who shall receive a salary of twelve pounds per month as from the 19th March, 1948, up to the date on which the elected council shall take office.

SECOND APPENDIX.

Times and Places.

1.—(1) The times, for the purposes of the election, shall be as follows :—

- (a) applications for insertion of names in the electors' list shall be made to the Town Clerk between the 19th March, 1948, and the 3rd April, 1948, and the Town Clerk shall, during the above-mentioned period, keep his office open to the public for meeting requirements in connection with any matter relating to the election, between 10 a.m. and 1 p.m. and 3 p.m. and 6 p.m. on every day during that period except on Sundays ;
- (b) the preparation and signing of electors' list by the Town Clerk shall be on the 7th April, 1948 ;
- (c) copy of the electors' list shall be kept open for public inspection between the 8th April, 1948, and the 14th April, 1948 ;
- (d) notice of appeal by persons claiming to have their names inserted in the electors' list and of objections by persons who claim that some person in the list is not entitled to have his name retained therein shall be given or made on or before the 14th April, 1948 ;
- (e) the list of persons objected to shall be kept open for public inspection between the 15th April, 1948, and the 17th April, 1948 ;
- (f) the election court shall be held by the Mayor between the 18th April, 1948, and the 22nd April, 1948, and the Town Clerk shall give three days' notice thereof ;
- (g) claims and objections under section 15 of the Laws shall be made not later than 30th April, 1948 ;
- (h) the decision of the President of a District Court under section 15 of the Laws shall not be later than 8th May, 1948 ;
- (i) notice of election under section 19 of the Laws shall be on or before 15th May, 1948 ;
- (j) the elected council shall come into office on the 1st June, 1948.

(2) The regulations for preparation and revision of electors' lists and the forms set out in the First Schedule to the Laws, together with the forms set forth therein, and the provisions of the Second, Third, Fourth and Fifth Schedules to the Laws shall be complied with as far as possible.

2. For the purposes of the election and this notice, the Mukhtar's office in Athienou shall be deemed to be, and shall be used as, the municipal office and the office of the Town Clerk.
