# THE SUMMER RESORTS (DEVELOPMENT) LAWS, 1938 AND 1946.

## SANCTION OF ACQUISITION OF LAND UNDER SECTION 29.

Whereas the Summer Resort Development Board for Platres have, by a resolution of the appropriate majority, under section 27 of the Summer Resorts (Development) Laws, 1938 and 1946, decided that the land described in the Schedule hereto should be acquired for the purpose of extending the Power Station at Platres;

And whereas the provisions of sections 27 and 28 of the aforementioned Laws have been complied with :

Now, therefore, I, the Acting Governor, in exercise of the powers conferred by section 29 of the Summer Resorts (Development) Laws, 1938 and 1946, do hereby sanction the acquisition of the land described in the Schedule hereto for the purposes hereinbefore set out.

### SCHEDULE.

All that land in the village of Pano Platres together with the buildings standing thereon, adjoining and situated to the west of the Power Station, comprising Plots Nos. 113/2/1, 114/2/1 and 196/5/1 of the Government Survey Plan of the village of Pano Platres; all which area is 1 evlek and 3,150 square feet, or thereabouts, in extent and is more particularly defined as the area coloured red on the plan dated 12th January, 1949, and signed by the Chairman, Platres Summer Resort Development Board.

#### NOTICE UNDER REGULATION 6.

It is hereby notified for general information that, in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940 to 1944, His Excellency the Acting Governor has been pleased to declare that the areas set out in the Schedule hereto forming part of the areas Gazette: of land and forests specified in Part I of the Schedule to the Minor State Suppl. No. 3: Forest (Trikomo Group) Order, 1941, shall be reserved as a Village Fuel 30.12.1940 Area for the village of Ayios Andronikos (Topju Keuy) in the District of Famagusta.

#### SCHEDULE.

(i) The whole of Stalos Forest Block 1 under plot No. 15, sheet XV, plans Nos. 9E. and 17E. and plot No. 82 of sheet XV, plan No. 18W. and plot 5 of sheet XV plan 26W. comprising 817 donums and one evlek approximately but excluding plot No. 51 of sheet 15 plan 17E. and plots Nos. 27 and 53 of sheet 15 plan No. 18W. as shown on the Government Survey Plan Serial No. 1401 delineated thereon in green and marked "Block 1".

(ii) The whole of Stalos Forest Block 2 under plot No. 30 of sheet XV, plan No. 26W. comprising 109 donums and 2 evleks approximately as shown on the Government Survey Plan Serial No. 1401 delineated thereon in green and marked "Block 2".
